
It was moved and seconded to obtain labor and material bid to replace the windows on the east side of the clubhouse, the west side has been completed several years ago.



We felt compelled to write to you after Wednesdays monthly meeting.

We were surprised to hear about the amount of damage that the ball field suffered following the recent car show. It is our feeling that if the ball field is continuing to be used on a regular basis, the repairs need to be made ASAP so as to avoid any injuries to people playing on the field.

It will take time and money to effect the repairs. We know there are people ready and willing to volunteer; and as the car show netted a profit of \$ 11,000 there is plenty of money to take care of the matter. The girls softball team who regularly uses the field should not, in our opinion, be asked to pay for repairs.

We were also surprised to hear John Rossi say that the De Carli and Mellor families donated the money for the ball field with the condition that the cars in the annual car show could park on the field.. We were not aware that conditions could be placed on donations.
